Overage: \$15.75 per ½ ERU after 1st ERU (ERU = 8,500 gallons)

Overage for sewer applies only to commercial and industrial users.

ALL WATER/SEWER ACCOUNTS

Shut Off/Reinstatement Fee: \$50.00 if disconnected for nonpayment
Late Fee: \$10.00 when account is past due
Account Set Up: \$25.00 charged for new accounts

Note: \$25.00 is also charged to a customer that has requested disconnection and is then reconnected (using same customer/account) after 90 days have passed following disconnection. Customers who reconnect within 90 days are not charged the \$25.00.
