A RESOLUTION OF THE CITY OF BINGEN

AUTHORIZING INTERFUND LOAN TO THE WATER CAPITAL RESERVE FUND

FROM THE SEWER CAPITAL RESERVE FUND IN THE AMOUNT OF \$103,000 AND

SETTING REPAYMENT AND INTEREST CALCULATIONS

WHEREAS, the City of Bingen experienced a failure of the water SCADA system on

August 22; and

WHEREAS, this failure caused a communications failure between the city's water

sources and the city's "old reservoir" causing damage to the reservoir; and

WHEREAS, the City of Bingen finds that the replacement of the reservoir is necessary to

be able to provide water to city; and

WHEREAS, the City of Bingen has been approved for a loan by the United States

Department of Agriculture Rural Development in the amount of \$952,500; and

WHEREAS, the City of Bingen is required to fund an Applicant Contribution to the loan

in the amount of \$103,000; and

WHEREAS, the City has determined that an interfund loan from the Sewer Capital

Reserve Fund in the amount of \$103,000 is the most appropriate method for supplying the Water

Capital Reserve Fund short term funding for three years; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BINGEN,

WASHINGTON DO RESOLVE AS FOLLOWS:

Section 1. Amount of Interfund Loans

The Sewer Capital Reserve Fund will loan the Water Capital Reserve Fund \$103,000.

Section 2. Repayment and interest calculations.

Resolution 2019-001
Authorizing Interfund Loan to

- A. The Water Capital Reserve Fund will repay the principal of the interfund loan plus interest by December 31, 2021.
- B. The Water Fund will pay 2.4947% interest, based on the State of Washington Local Government Investment Pool Anticipated Gross Earnings Rate as of January 31, 2019 to the lending fund.
  - C. The maximum repayment schedule shall be as follows:
