Section 1. The following items are to be surplus as directed by the Mayor and/or designee, and may include a direct sale:



- Mauldin Street Roller Compactor


Section 2. Funds received from the sale of the 1988 Ford Dump Truck shall be deposited equally between 153 – Street Equipment Fund, 305 – Park Construction and Maintenance Fund, 421 – Water Capital Reserve Fund, and 423 – Sewer Capital Reserve Fund. Funds from the sale of the 1997 Ford Explorer shall be deposited 001 – General Fund for benefit of the Animal Control program. Fund from the 2003 John Deere Mower 355D shall be deposited

equally between 101 – Street and 305 – Park Construction and Maintenance Fund. Funds from the 1960 Ingersol Rand Air Compressor trailer shall be deposited into 153 – Street Equipment Fund. Funds from the Mauldin Street Compactor shall be deposited into 153 – Street Equipment Fund.
