

RESOLUTION NO. 2019-003

A RESOLUTION OF THE CITY OF BINGEN ESTABLISHING 2019 SALARY SCHEDULE FOR NON-UNION REPRESENTED EMPLOYEES

WHEREAS, the City of Bingen has determined that it is appropriate to provide a 2.80 percent cost of living increase and a \$2.00 per hour one-time wage schedule adjustment for 2019 for non-union represented employees effective January 1, 2019; and




