

**RESOLUTION NO. 2022-003**

**A RESOLUTION OF THE CITY OF BINGEN**

**CANCELLING CERTAIN WARRANTS AND CHECKS ISSUED BY THE CITY**

**WHEREAS**, RCW 39.72.010 provides that municipal corporations of the State of Washington may issue duplicate warrants and/or checks in the case of the loss or destruction of warrant or check for the payment of money or other instrument of indebtedness; and

**WHEREAS**, it has been brought to the attention of the City Council that the warrants and checks listed below have been lost or stolen and have not been presented for payment; and

**WHEREAS**, pursuant to RCW 43.08.066 affidavits concerning the loss or theft have been secured from the proper owner, payee, or legal representative of such owner or payee of the original instrument; and

**THE CITY COUNCIL OF THE CITY OF BINGEN, WASHINGTON DO RESOLVE AS FOLLOWS:**

Pursuant to RCW 39.72.010, the City Administrator of the City of Bingen shall cancel the original checks and warrants and issue duplicates to the appropriate payees.


