The meeting was called to order by Mayor Betty J Barnes at 7:02 p.m. Council members present: Catherine Kiewit, Phil Jones, Ryan O'Connor, Isolde Schroder, Joseph O'Sullivan. Public Comment

Carl Warren asked about the emergency response plan for Bingen Point and current efforts to prepare for COVID-19.

Mayor Barnes explained that the emergency response plan was up to date and in place, and said she would be participating in FEMA training through the Emergency Operations Center tomorrow.
