## Minutes of July 7, 2020 Regular Council Meeting

### Skatepark

Council member O'Connor made a motion to keep skatepark closed until Phase III or until further information is brought forward. Council member O'Sullivan seconded the motion and it passed unanimously.

Mayor Barnes said she attended a meeting at WWTP and they may need change orders by the next meeting.

Mayor Barnes said that she was told to request a reimbursement from the State out of the Quiet Zone Fund for the amount that was paid to BNSF.

Council member Jones made a motion to request a reimbursement from WA State for amount that was paid to BNSF from the Quiet Zone Fund. Council member O'Connor seconded the motion and it passed unanimously.
