# **BINGEN CITY COUNCIL MINUTES**

## November 16, 2021

### Meeting Via Teleconference - Audio Recorded

The meeting was called to order by Mayor Betty J. Barnes at 7:02 pm. Council members present: Phil Jones, Joseph O'Sullivan, Ryan O'Connor and Catherine Kiewit. Council members absent: Isolde Schroder. Staff present: Deputy Clerk Dena Riggleman, City Attorney Christopher R Lanz. Audience Present: Jan Brending and Jacob Bertram.

## Minutes of November 02, 2021 Regular Council Meeting

Council member Kiewit made a motion to approve the minutes from the November 2, 2021 regularly scheduled City Council meeting. Council member Jones seconded the motion and it passed unanimously.

#### Amending BMC 13.24.030 Monthly Sewer Billing

Jan Brending said that the Ordinance for the monthly sewer billing allows for a 5% increase every year so the council does not need to redo the Ordinance unless the city deviates from the allowed increase.

Council member Kiewit made a motion to remove the public hearing and amending the proposed Ordinance for the monthly sewer billing from the agenda. Council member O'Sullivan seconded the motion and it passed unanimously.

# Amending BMC 13.04.1200 Monthly Water Billing

Jan Brending said that the Ordinance for the monthly water billing allows for a 5% increase every year so the council does not need to redo the Ordinance unless the city deviates from the allowed increase.

Council member O'Sullivan made a motion to remove the public hearing and amending the proposed Ordinance for the monthly water billing from the agenda. Council member O'Connor seconded the motion and it passed unanimously.

#### Ordinance 2021-08-719 Advalorem Taxes

Council member Jones made a motion to approve Ordinance 2021-08-719 Advalorem Taxes. Council member Kiewit seconded the motion and it passed unanimously.

## **Resolution 20221-006 Advalorem Taxes**

Council member Jones made a motion to approve Resolution 2021-006 Advalorem Taxes. Council member Kiewit seconded the motion and it passed unanimously.

#### Public Hearing – 2022 Draft Budget

Jan Brending said she has been helping Dena Riggleman to balance the 2022 Budget. Brending explained that the budget is allowing for the highest pay step for the open position in either a City Clerk or a City Administrator and the proposed 5.5% cost of living increase for the employees, which the city is still in Union negotiations, at the moment.

Brending discussed all the major projects the city has undertaken recently and how the city is currently in the middle of a three-year audit for the years 2018-2020.

Brending said that the city will have to move funds from the Community Development, General Equipment, Building Construction and Maintenance and the Park Construction and Maintenance Funds to help balance the 2022 Budget. Brending said that there is a possibility that the 2021 Budget will have excess funds which could cover these amounts and the funds could then be moved back to these places.

Mayor Barnes closed the public hearing for the 2022 draft budget.

#### Ordinance 2021-09-720 2022 Budget

Jan Brending said that the city will hold a public hearing on the Final 2022 Budget on the December 7<sup>th</sup> council meeting and then the council can vote on the ordinance then.

Council member Kiewit made a motion to table Ordinance 2021-09-720 2022 Budget, until the next council meeting on December 7<sup>th</sup>. Council member O'Sullivan seconded the motion and it passed unanimously.
