Minutes of September 17, 2019 Regular Council Meeting

2nd Public Hearing - Proposed Ordinance 2019-09-670 Adopting BMC Chapter 8.22, Checkout Bag Regulation


Mayor Barnes opened the public hearing on proposed ordinance 2019-09-700.

The third document shows the difference in pncing between paper and plasti bags given to WFIA by one of our members, Bunzl Distribution - a major distributor of paper and plastic bags throughout Washington State Tibe leve Becky Miles, a wonderful advocate for a plast libag ban, has already given the last two documents to you.

We encourage you to pass the pla t bag ban as long as there is a 10 cent pass-through charge and an alternative to pape bags such as the 2.25 m reusable plastic bag. Please let me know you have any questions

Brad Bookmeyer spoke in favor of the ordinance and asked those in the audience in support of it passing to raise their hands. Twelve people raised their hands.

Candi Didier spoke in favor of the ordinance and said she thought heavier bags were great and very useful.

Becky Miles spoke in favor of the ordinance and said thought she is not a Bingen resident she does shop in Bingen and supports the town in that way.

Council member Kiewit said she had examined the ordinance and she was in support of passing something like it. Kiewit said she had some minor revisions and questions. She asked if it was true that Klickitat County residents could no longer recycle plastic single-use grocery bags any longer.

Becky Miles explained that plastic single use bags were no longer being accepted for recycling in Klickitat County, mainly due to the damage they cause to the sorting and processing equipment in the recycling industry. She noted that she found a page on the Klickitat County Solid Waste website that still incorrectly listed the bags as recyclable, but said she brought it to Recycling Coordinator Averie Morgan's attention and was told that the page would be removed as soon as possible.

Mayo Barnes closed the public hearing.

Proposed Ordinance 2019-09-670 Adopting BMC Chapter 8.22, Checkout Bag Regulation The ordinance number was corrected to 2019-12-700.

Council member Jones made a motion to adopt Ordinance 2019-09-700 with changes made. Council member O'Connor seconded the motion and it passed unanimously.

Museum Contract Renewal

Council member Mann moved to authorize Mayor Barnes to sign a two-year extension of the museum lease agreement. Council member Jones seconded the motion and it passed unanimously.

Public Hearing - Proposed Ordinance 2019-10-671 Amending BMC 13.04.120, Service Classifications and Charges Designated for Water Service

Mayor Barnes opened the public hearing on proposed ordinance 2019-09-701.

Clerk Treasurer Willey explained that she recommended a 10% increase in water rates based on the preliminary budget information compiled.

Council member Mann asked if the rate schedule was fair and equitable for residential and commercial consumers.

Clerk Treasurer Willey explained how the tiered system for residential users balanced with the commercial single rate system for water usage charges.

The council asked for a rate comparison from other local cities to be provided before a decision was made.

Mayor Barnes closed the public hearing.

The ordinance number was corrected to 2019-12-701.

Public Hearing - Proposed Ordinance 2019-11-672 Amending BMC 13.24.030, Monthly Sewer Billing

Mayor Barnes opened the public hearing on proposed ordinance 2019-09-702.

Clerk Treasurer Willey explained that she recommended a 5% increase in sewer rates based on the preliminary budget information compiled.

The council asked for a rate comparison from other local cities to be provided before a decision was made.

Mayor Barnes closed the public hearing.

The ordinance number was corrected to 2019-12-702.

Public Hearing - Proposed Ordinance 2019-12-673 Adopting Proposed 2019 Advalorem Property Tax

The ordinance number was corrected to 2019-12-703.

Council member Kiewit made a motion to adopt Ordinance 2019-09-703 as corrected. Council member Mann seconded the motion and it passed unanimously.

Proposed Budget Increase to WWTP Ecology Funding Application WQC-2020-Bingen-00072

Council member Kiewit made a motion to table the proposed budget increase until Nancy Wetch with Gray and Osborne was able to appear at a council meeting to explain the request. Council member O'Connor seconded the motion and it passed unanimously.

Resolution 2019-005 Affordable Housing Tax

Mayor Barnes explained that the proposed resolution mirrored that passed by the Klickitat County Commissioners.

The resolution document number was corrected to 2019-005.

Council member Mann asked why an ordinance was not being presented at the same time as the resolution.

Mayor Barnes explained that the council first needed to establish their intent to meet the deadline set by the State, and that there would be more time to pass an ordinance after a resolution was passed successfully.

Council member Mann made a motion to approve Resolution 2019-005 as corrected. Council member O'Connor seconded the motion and it passed unanimously.

Staff Update

Fall Clean Up

Public Works Superintendent Spratt said that the Fall Clean Up event would be November 20-25, 2019.

Street Sweeper

Public Works Superintendent Spratt said the street sweeper rental option in Hood River was just a truck with a broom, not made for streets with curbs or streets in residential areas.

Mayor Barnes suggested making a list of larger items needed for budget purposes and recommended looking through the State surplus items.

The Council asked Spratt why White Salmon's Street Sweeper was not a good option. Spratt explained that White Salmon's street sweeper was costly to use and that there had been issues with timeliness and availability in the past.

Mayor and Council Comments

Mayor Barnes reported that she had attended the recent *It Takes a Village* event and said it was a nice event and she hoped that it would continue to build and grow in the future.

Barnes said she had also attended *Digging In*, an event connected to the Our Klickitat group. She said the event was held at the Society Hotel in Bingen and featured small group discussions with area youth.

Barnes said the format of the *Digging In* event was very useful as the adults spent the evening listening to the youth and got to hear what they felt they needed from the community. She said the main topics of discussion were suicide, drug use, peer pressure, and parenting. Barnes said the event was very eye-opening and interesting. She noted that mental health was a very big issue and that she and the other adults had been thinking about what could be done to help.

Mayor Barnes said she met with Ruby Irving from Klickitat County Solid Waste to discuss the agreement between the County and the City of Bingen since the agreement had not been updated since 1990. She said the agreement would be in front of the council at the next meeting.

Council member Kiewit said after the last council meeting she had reached out to her peers that work with the Art of Community group in Hood River to talk about their program. She said their organization had been formed because the City of Hood River had been bequeathed art work and was reluctant to facilitate a public art project. She said the group was a nonprofit, run by volunteers. Kiewit said she had reached out to the North Shore Community Foundation and introduced the two groups so they could coordinate since the Art of Community program was well established and could possibly serve as a model of operations.

Mayor Barnes said it would be interesting to find out how much the Hood River City Council is involved with art placement and said she would like to learn about how the Art of Community model worked.

Council member Mann asked Public Works Superintendent Spratt how the recycle site had fared with the closure of the cardboard collection bins.

Spratt said the last week had been horrible and that several truckloads of litter had been left scattered around the property by County Residents that did not read the signage and illegally dumped their recycling and also garbage all over the ground.

Executive Session

Mayor Barnes announced at 9:30 pm that the City Council will go into Executive Session for 10 minutes to discuss potential litigation pursuant to RCW 42.30.110(1)(i).

At 9:40 p.m. the Council resumed regular session.
